

Review/Documentation of Existing Evaluation Data

A team, composed of IEP members (34 CFR 300.321) and other qualified professionals, as appropriate, must review existing evaluation data, including: 34 CFR 300.305(a)(1)

- Evaluation and information provided by the parents of the child; 34 CFR 300.305(a)(1)(i)
- Current classroom based, local, or State assessments, and classroom-based observations; 300.305(a)(1)(ii) and
- Observations by teachers and related providers. 300.305(a)(1)(iii)

NOTE: A public agency must evaluate a child with a disability in accordance with 34 CFR 300.304-300.311 before determining that the child is no longer a child with a disability. [34 CFR 300.305(e)(1)]

EXCEPTION: Reevaluation is not required before the termination of eligibility due to graduation from secondary school with regular diploma, or due to exceeding the age eligibility for FAPE under State law [34 CFR 300.305e(1)], but the public agency must provide the child with a summary of the child’s academic achievement and functional performance, which shall include recommendations on how to assist the child’s postsecondary goals. 34 CFR300.305(e)(3)
